Indemnity & Acceptance of Liability:

- I hereby warrant that, to the best of my knowledge, the Minor is in good health and I assume all responsibility for the health of the Minor.
- In the case of a medical emergency, I hereby give consent to the doctor chosen by Hillsong Africa Foundation and Hillsong Church, its staff, volunteers or other team members and representatives, to secure proper treatment for and/or order hospitalisation, injection, anaesthetic, or surgery for the Minor should such consent be required for medical reasons on an urgent basis and should it not be possible for the next of kin to be contacted immediately. I understand that every effort will be made to contact me prior to instituting such procedures.
- I, in my personal capacity, and on behalf of the Minor, agree to indemnify and hold harmless the Hillsong Africa Foundation, Hillsong Africa Church, its staff, volunteers or other team members and representatives in respect of any claims which may be brought against any of them, arising of injury, death, property loss sustained by the Minor whilst participating in any of the

Activities, whether such loss, damage, or injury results from the negligence, and/or gross negligence, or from any other cause including injuries that may be suffered by the Minor before, after and during the Activities.

Media Consent & Release Agreement:

Any statements I make that are recorded by Hillsong Africa Foundation & Hillsong Church will be original to me and will not violate or infringe on rights of any person or entity including copyright. Hillsong Africa Foundation & Hillsong Church is not obliged to use the Recordings otherwise.

I release Hillsong Africa Foundation & Hillsong Church from all claims, demands and actions in connection with or resulting from the exercise of rights granted in this release.

Hillsong Africa Foundation & Hillsong Church is entitled to rely on this release. I waive my rights at any time to seek injunctive or other relief to prevent or restrict Hillsong's use of the Recordings.

I agree that this consent is valid for 5 years from the date on this form, and I may be given the option to renew consent upon expiry.

I agree that Hillsong Africa Foundation & Hillsong Church shall not pay me any fees or royalties in connection with my contribution to the Recordings;

I will not bring any claim or commence proceedings of any other nature against Hillsong Africa Foundation & Hillsong Church or any other person or entity in respect of the exercise of rights granted in this release.
